The Governor's Workforce Development Board (GWDB) is the Governor's chief policy-making body for workforce development in the State of Maryland.

To create an opportunity where every person maximizes his or her career potential and employers have access to the human capital they need to be competitive.



CHANGING The State Board Composition (GWDB) Maryland for the Better

The Governor

Representatives appointed by the Governor including:

Business representatives (which represent a business majority of 51 percent)

Workforce representatives (which includes labor organizations)

State government representatives (which are agency officials)

One member of each chamber of the State Legislature

Characteristics of the GWDB

Governance

Supports board decisions (internally and externally) and can enlist the support of others to accomplish workforce development objectives

Vision

Future focused to meet the needs of Maryland's business community and workers

Strategic Thinking

Contributes their knowledge and expertise to assist in all areas of sector strategies

Ambassadorship

Communicates and acts as an advocate for GWIB and the community

The development, implementation and modification of the State plan under the Workforce Innovation and Opportunity Act of 2014 (WIOA)

The review of statewide policies and programs and the recommendations on actions to align workforce development programs in a manner that supports a comprehensive and streamlined workforce development system in the State

GWDB Responsibilities


The development and continuous improvement of the workforce development system in the State

The identification of regions, the designation of local areas, and the improvement of the one-stop delivery system to local areas to support effective delivery of services to workers, jobseekers and employers




GWDB Responsibilities
